

# 2018 BEER, CIDER and WINE PRODUCTS Credit Calendar

## State of New York Division of Alcoholic Beverage Control State Liquor Authority

Section 101-aaa of the New York Alcoholic Beverage Control Law provides, in part, that ALL Retail Licensees (except package stores) who purchase BEER, CIDER and/or WINE PRODUCTS for resale (for on-premises or off-premises consumption) shall pay cash at the time of delivery, or on terms requiring payment no later than the FINAL PAYMENT DATE for the CREDIT PERIOD during which the delivery was made.

**The Alcoholic Beverage Control Law establishes the following CREDIT PERIODS, FINAL PAYMENT DATES, DELINQUENT NOTICE DATES, and NOTIFICATION DATES for 2018.**
